**STANDING ORDER**

Rule 5(a)(1)(A) of the Federal Rules of Criminal Procedure mandates “[a] person making an arrest within the United States must take the defendant without unnecessary delay before a magistrate judge . . . unless a statute provides otherwise.” Furthermore, Rule 5(c)(1) provides that “[i]f the defendant is arrested in the district where the offense was allegedly committed: (A) the initial appearance must be in that district.” Moreover, Rule 5(e) states “[i]f the defendant is charged with a misdemeanor only, the judge must inform the defendant in accordance with Rule 58(b)(2).”

This Court **FINDS** that law enforcement arrests, occurring within the District of North Dakota on federal lands maintained and operated by the National Park Service, National Forest Service, U.S. Fish and Wildlife Service, and Bureau of Land Management, of non-violent misdemeanor offenders, raise unique considerations. For example, individuals suspected of driving while intoxicated or suspected of possessing small quantities of controlled substances may pose a risk to the community if not arrested, yet after being arrested, these individuals would likely be released on their own recognizance at their initial appearances. However, in situations where federal law enforcement officers arrest individuals suspected of committing these types of non-violent misdemeanor offenses on nights, weekends, or holidays – when the Court is unavailable to conduct initial appearances – these individuals may unnecessarily spend multiple nights in custody awaiting their initial appearance before this Court. Therefore, to both maintain the safety of the community and to ensure that non-violent misdemeanor offenders are not unnecessarily confined prior to their initial appearance date, this Court issues the following order.

**IT IS ORDERED** that defendants arrested on federal land in the District of North Dakota, maintained and operated by the National Park Service, National Forest Service, U.S. Fish and Wildlife Service, and Bureau of Land Management, for non-violent misdemeanor offenses, may be released on their own recognizance or released to a third party in lieu of continued detention pending their initial court appearance. This Court authorizes federal law enforcement officers from these agencies to present the attached Release on Recognizance and Release to Third Party forms to suspects of non-violent misdemeanors offenses for their consideration and consent.

**IT IS FURTHER ORDERED** that if a defendant executes a Release on Recognizance or Release to Third Party form, the United States must submit to the Court the signed Release form along with the appropriate charging document the first business day following the arrest.
