Re: Locating Pretrial Detainees (updated to the October 29, 2018, memorandum)

Thank you for your participating in our district's Criminal Justice Act panel. The court appreciates the work that you do in representing your clients.

When your clients are detained, they are sometimes moved from one correctional facility to another. In order to facilitate locating your clients, USMS suggests the following:

- (1) Encourage your clients to call you immediately after a transfer.
- (2) Call the USMS and ask for a supervisor to confirm a client's location prior to any in-person visit: **Fargo: 701-297-5760** or **Bismarck: 701-333-0640**
- (3) Check for a client's location via correctional facility website or contact the facility.
